** Exhibitors allocated to the mobile halls will be entitled to a 5% discount on the unfurnished exhibition space prices. Exhibitors in Halls B -1 and B2 -1 will be entitled to a 10% discount on the unfurnished exhibition space prices.

The organizer reserves the right to restrict or prohibit the use of business tickets in cases where they are used for prize games or other promotional activities involving the distribution of a larger number of free tickets (more than 10).

7. Registration and ecological compensation

Registration: 330,00 EUR
Ecological compensation: 2,00 EUR/m²

Registration includes the application fee and the exhibitor's presentation on the fair's website. The ecological compensation covers the preparation of ecological stations for waste disposal during setup and dismantling, the provision of waste bags, and the removal of waste bags from exhibition spaces during the fair. Payment of the registration and ecological compensation is mandatory for all exhibitors.

8. The registration for exhibition space higher than 2.5 m.

For all exhibition spaces higher than 2.5 m, the exhibitor, based on the sketch of the exhibition space with marked basic dimensions, obtains written permission from the organizer and settles the mandatory registration for the exhibition space higher than 2.5 m (no later than 30 days before the assembly of the fair). The registration must also be settled if the individual elements (banners, flags, etc.) at the exhibition space exceed 2.5 m in height.

Registration 330,00 EUR

The organizer reserves the right to subsequently charge the exhibitor for the registration of exhibition space exceeding 2.5 m in height if it was not declared and the deviation is identified during setup or at a later stage.

9. Warnings

Prices are net of VAT (except Item No. 6), which shall be charged in accordance with the Value Added Tax Act and paid by the Exhibitor. The Organiser of the event reserves the right to modify prices based on the application of the clause "Impact of changed circumstances", which refers to circumstances that could not have been foreseen on the day the prices were defined (Article 112 of the Code of Obligations).

The order form and annex to this Application form - technical connections and equipment for the exhibition space - serve as an Annex to this Application form and will become a component to it once the organiser receives confirmation from the Exhibitor.

Exhibition Terms and Conditions

General provisions

Completion of the Application Form also serves as acceptance of the offer. The Exhibitor shall complete, sign and submit the application to the Organizer within the specified application deadline to the following address: Gospodarsko razstavišče d.o.o., Dunajska cesta 18, 1000 Ljubljana, or via e-mail to: dom@gr-si.

a) Application Forms that do not bear the signature of the authorised person of the company shall be deemed invalid.

b) The Application Form is legally binding and irrevocable for the Exhibitors.

c) The Organizer will not consider or accept Application Forms which contain reservations or proposals for amendments to the conditions contained therein.

d) The Exhibitor shall be obliged to fully comply with the General Terms and Conditions of Work at Gospodarsko razstavišče, as published on the Organizer's website, the hygiene guidelines of the National Institute of Public Health (NIJZ) for the organisation of events, and any additional instructions issued by the Organizer.

e) The prices which are valid for the event are stated on the front page of the Application Form. The exhibition programme data specifications are the conditions that need to be met for the Exhibitor to participate in the event. The Exhibitor may exhibit only the exhibition programme for which the application is submitted.

f) The Organizer reserves the exclusive right to decide upon accepting any offers submitted (Application Forms). The Organizer is also not obliged to consider Application Forms received after the due date.

g) The smallest Exhibition space which an Exhibitor may request is 6 m².

h) We hereby give our consent to Gospodarsko razstavišče d.o.o. to process our above data in accordance with the Personal Data Protection Act for use in its own files for the following purposes: statistical processing, participant segmentation, fulfilment of contractual and legal obligations, sending offers, advertising material, publications and invitations to events, and the carrying out of consumer surveys by telephone, post or email. The data may be processed by Gospodarsko razstavišče d. o. o. for up to 10 years following our most recent participation at the Fair or other Event, or until termination of written authorisation on the condition that the legislation in place does not impose any other time limitations.

2. Allocation of exhibition space

Domestic and foreign exhibitors may exhibit at the Event on the condition that the products and services exhibited are in accordance with the Event programme. Commercial agents and importers may exhibit products on behalf of the companies they represent. The Organizer is responsible for granting the Exhibitors access to the Event, allocating Exhibition space, and managing the Exhibition space for the benefit of the Event. The Organizer may, in order to optimise exhibition surfaces, assign an Exhibitor a space with less open sides than requested. The Organizer reserves the right to allocate up to approximately 30% less or 10% more than ordered. Exhibition space than requested by an Exhibitor. Any change to the Exhibition space assigned must be authorised by the Organizer. The Organizer may reallocate or close hall entrances and exits and, if so required, make other changes to the Exhibition space. If, for any reason, the Event Organizer is unable to allocate an Exhibition space to an Exhibitor upon receipt of his application, the Exhibitor is entitled to a full refund of the sum paid.

3. Cancellation of the Application

An Exhibitor may cancel a submitted application only by way of a written statement. In the event of such, the Exhibitor is obliged to pay:

- the registration fee and 50% of the exhibition space fee if the application is cancelled up to and including 15 January 2027;
- the registration fee and 100% of the exhibition space fee if the application is cancelled from 16 January 2027 onwards.

4. Registration and ecological compensation

Each Exhibitor is obliged to pay the ecological compensation and registration.

Registration for the fair includes the application fee and the exhibitor's presentation on the fair's website. Exhibitors must submit their data for website entry upon registration or no later than 30 days before the event. If the exhibitor submits the data less than 30 days before the event or fails to do so, only basic general information about the exhibitor will be published on the website. The organizers reserve the right to shorten and adjust the website entry accordingly but are not responsible for any errors.

5. Payment

The Exhibitor undertakes to pay for the Exhibition space, the ecological compensation and the registration for the Event, at the prices agreed and specified in the Application, as well as for any additional orders at the prices set out in the Additional Order Form. VAT is not included in the stated prices and shall be paid by the Exhibitor.

Following submission of the signed Application to the Organizer, the Exhibitor shall receive a Pro Forma Invoice, which must be paid in full (total amount) within the deadline stated therein. Payment of the Pro Forma Invoice shall be a prerequisite for the Exhibitor's participation at the Event.

The Organizer undertakes to issue invoices in accordance with the legislation in place. In the event of late payment, the Organizer may charge statutory interest on arrears to the Exhibitor.

The Exhibitor may appeal the service provided in writing no later than 8 days following the issue date of the invoice.

If the Exhibitor appeals only part of the Invoice, he is obliged to pay the undisputed part by the deadline and in the manner defined by this application.

6. Confirmation of the allocation of the exhibition space

Upon receipt of the first instalment payment based on the issued Pro Forma Invoice, the Organizer shall confirm receipt of payment in writing. Thereby, the allocation of the exhibition space shall be deemed confirmed.

7. Cancellation of the allocation of the exhibition space

The Organizer reserves the right to refuse the Application Form or annul the confirmation issued as per clause 6 of the Application Form in the following cases:

1. if at the time of application the Exhibitor is in settlement, bankruptcy, or winding-up proceedings;
2. if the Exhibitor has outstanding past debts owed to the Organizer;
3. if the objects to be exhibited in the event do not suit the theme of the event;
4. if the Exhibitor fails to supply the documents required by the Organizer (as stated in clause 14);
5. if the Application Form is received after the due date;
6. if the Exhibitor does not pay the pro forma invoice within the deadline stated.

8. Duration and location of exhibition

If the exhibition has to be postponed or started at an earlier date than scheduled, its duration has to be shortened or extended, or the exhibition has to be re-located, the Exhibitors do not have the right to cancel their participation in the exhibition or to claim damages.

9. Technical conditions

The exhibitors shall submit to the Organizer an outline (scheme) of the set-up and equipment in place for their own exhibition spaces. The schemes are to be confirmed by the Organizer prior to assembly. The height of the exhibition stand may not exceed 250 cm.

If a higher exhibition stand is required, the Organizer's written permission must be obtained. When assembling the exhibition stand, the Exhibitor may not operate beyond the exhibition area it has been allocated.

10. Accreditations for Exhibitors

Upon confirmation of the exhibition space, the Exhibitor shall receive exhibitor accreditations for personnel present at the exhibition space. The number of accreditations shall be determined by the Organizer in the 'Instructions for Exhibitors'. Accreditations shall contain the holder's photograph, first name and surname and are non-transferable. In the event of misuse, the Organizer reserves the right to revoke such accreditations

11. Assembly, disassembly

Assembly and disassembly must be registered in advance at the fair reception desk. The assembly and disassembly deadlines stated in the "Instructions for Exhibitors" are to be strictly observed. If the disassembly term is exceeded, the Organizer reserves the right to disassemble the exhibition stand at the Exhibitor's own risk and expense. When disassembly is completed, the Exhibitor shall restore the stand to its original state; failing this, the Exhibitor is obliged to compensate the Organizer for any damage sustained. When setting and furnishing the exhibition stand during assembly, while the event is in progress, and during disassembly, the Exhibitor or its Contractor shall consider and comply with the following:

- health and safety at work regulations;
- fire safety regulations;
- general conditions of work on the exhibition grounds (stated on the Organizer's web page);
- "Instructions for Exhibitors" which are received by Exhibitors when allocated exhibition space.

The Exhibitor may not remove exhibits from the exhibition stand until the event has concluded. The Exhibitor may only leave the exhibition stand before the event has concluded upon the written approval of the Organizer.

12. Guarantee and insurance

a) The Organizer shall not be held responsible for any damage, loss, destruction, or property theft (to exhibits, equipment, and the like) sustained by the Exhibitor or its Contractor, their staff and third parties, or damage caused by fire, storm, hail, lightning, breakages, water leakage, theft or any other reason. The Organizer shall not be held responsible for any damage, loss, destruction, or theft sustained by third parties, nor for any injuries to third parties caused by the Exhibitor or its Contractor at the Fair or on the exhibition grounds. The Exhibitors and their Contractors shall obtain insurance at their own expense.

b) The Exhibitor, its Contractor or any of their staff will be held responsible for any damage or injury caused by them to the Organizer and/or third parties at the exhibition space or on the exhibition grounds.

c) The Organizer does not assume responsibility for vehicles left on the exhibition grounds and parking spaces by Exhibitors, their staff or authorised persons and their Contractors.

d) The Exhibitor may not lease the allocated exhibition space, advertising space or any of their parts to any third party. In the event that this condition is breached the Organizer reserves the right to charge the Exhibitor a further 100% of the price of the exhibition and advertising space allocated.

e) Prior to the opening of an event, the exhibitor is obliged to check his exhibiting space for unknown objects. If such an object is found, the exhibitor is obliged to immediately inform, by telephone or in person, the reception of the GR - Ljubljana Exhibition and Convention Centre.

13. Presentations

No later than 8 days before the commencement of the exhibition, the Exhibitor shall submit written notification to the Organizer of any events to be held on the allocated exhibition space (e.g. a music performance).

The Organizer reserves the right to restrict or prohibit presentations

that may cause noise, dirt, dust, gas leaks or otherwise hinder the smooth running of the event, irrespective of whether the Organizer has already issued a written consent for these presentations. Presentations shall be performed exclusively on the exhibition space allocated.

Any obligations relating to copyright and related rights shall be borne and settled by the Exhibitor organizing such activities

14. Activity of the Exhibitor – documents

Before the allocation of the exhibition space has been confirmed, the Organizer reserves the right to require the following documents from the Exhibitor:

- A business permit or business registration certificate issued by a relevant authorised office which proves that the Exhibitor fulfils the conditions for carrying out business, as provided by law.
- Appropriate consent from the relevant sanitary and veterinary inspectorate if the Exhibitor plans to trade in foodstuffs and general consumer goods, organise food tasting, present general consumer goods or perform catering services;
- Proof of insurance of persons and effects.

The Organizer reserves the right to cancel the participation of the Exhibitor if the Exhibitor fails to supply the documents required. By signing this application form, the Exhibitor confirms that among his registered business activities he has a business activity that complies with his presentation at the fair. In case of violation, the Exhibitor is fully responsible for his actions.

15. Photography and drawing

The Organizer reserves the right to take photographs of the exhibition spaces and exhibits, as well as draw them, or film them, and the material obtained may be used by the Organizer for personal or general use. The Organizer renounces all contestations arising from copyright. With the exception of the Exhibitor's own space, the photographing, drawing or filming of exhibition spaces is prohibited without the authorisation of the Organizer.

16. Cleaning the exhibition stand

The Organizer provides for the cleaning of the exhibition grounds and hall corridors. Each Exhibitor is responsible for cleaning its own exhibition space; however, the Exhibitor may request that the Organizer assumes cleaning duties at the expense of the Exhibitor.

17. Jurisdiction

The Organizer and the Exhibitor agree that any disputes will be resolved amicably. In cases where the contracting parties cannot reach an agreement, they agree to confer jurisdiction to the competent court in Ljubljana.
